- 1 The conference organising committee reserves the right to amend the partnership packages to benefit the sponsor, conference and delegates.
- 2 Partners and Exhibitors will be selected based on their ability to meet conference requirements. The organising committee reserves the right to review all display materials provided by a Partner or Exhibitor and/or with discretion, refuse any application.
- 3 All Partners and Exhibitors must comply with the principles that their sponsorship must:
  - a. withstand professional and public scrutiny,
  - b. conform to professional and community standards of ethics and good taste,
  - c. not bring PHC RIS, Flinders University and/or the industry into disrepute.
- 4 The conference organising committee reserves the right to vary the quoted prices in accordance with any change to the legislated rate of GST (currently 10%). All packages shown are GST inclusive and this component will be displayed on the tax invoice.
- 5 Partnerships will only be confirmed on receipt of a signed application form and deposit:
  - a. A tax invoice will be issued for all cash sponsorships with acknowledgement being given on the receipt of the signed application form and a deposit (50% of total sponsorship cost). Final payment is due 14 May 2010.
  - b. All applications received after 15 May 2010 must be accompanied by full payment.
- 6 In the event of a cancellation by a Partner:
  - a. The deposit is non-refundable. A refund will be provided for any additional monies paid for cancellations received within one month of application and before 14 May 2010.
  - b. No refunds of sponsorship monies will be given for cancellations received after 14 May 2010.
- 7 The delivery of sponsorship and exhibition entitlements will be provided subject to the Partners/Exhibitors application meeting production timelines.
- 8 Exhibition stand bookings will be confirmed upon receipt of the booking form and deposit payment (50% of the exhibition fee); the balance is due by 30 May 2010. Please note that the deposit is non-refundable.
